New Features and Enhancements in erwin Mart Portal

Following new features and enhancements are available in erwin Mart Portal 12.5..

Enterprise Modeling Compliance

Enterprise modeling Compliance (EMC) provides a mechanism for mart-privileged, non-administrator users to apply metadata standards across mart catalogs in order to maintain quality of data models at the enterprise level. Using EMC, you can create customized data compliance policies and rules for data models saved to Mart. You can also create user-defined jobs to apply these policies to the models and generate comprehensive reports with pass, error, and warning statistics.

Enhancements

erwin Mart Portal has undergone several enhancements as follows:

- Email addresses or user name, individually as well as together are supported as your default selector instead of only username. You can configure this under settings to be displayed across erwin Mart Portal and erwin ER360.
- The catalog tree displays a Sensitive Data Indicator, SDI tag for models that contain sensitive data.
- Ability to control the level of permission and assign a user or a group to a profile, library, or model has been added.
- View as a permission at library level has been added.
- Using the Project Explorer in erwin DM, you can save projects and their models to mart under catalogs.
- You can generate Personal Access Tokens for REST API via Settings.
- User device tracking for logs is supported.

Known Issues

Following is a list of known issues in erwin Mart Portal and erwin ER360:

erwin Mart Portal

Issue	Description
Error msg is displayed when the DI model is opened in erwin DM - Checkout Enabled	<p>When you open a model imported from erwin Data Intelligence (erwin DI) via DM Connect for DI, an error is displayed even though the model is imported correctly.</p> <p>Click OK on the error message to proceed.</p>
erwin Mart - Cassandra: Exporting Cassandra model into DI displays the Column Definition value in Column Comments	<p>The export of a Cassandra model into erwin DI using DM connect for DI is displaying unwanted values in erwin DI .</p> <p>After the export, the Column Definition value is displayed in the Column Comments.</p>
erwin Mart - Azure SQL: The Settings and DI Configuration tabs do not display password	<p>The Settings and DI Configuration tabs do not display user password in the erwin Mart Portal that is configured with Azure SQL.</p>
erwin Data Modeler cannot Connect to erwin Mart Portal on Host Machine	<p>erwin Data Modeler (DM) cannot connect to the erwin Mart Portal (MS) on an erwin Mart Portal host machine.</p> <p>This happens because the client application version is different from the erwin Mart Portal version.</p> <p>To counter this issue, do the following:</p> <ol style="list-style-type: none"> 1. Open Internet Explorer. 2. Click Internet options. 3. Go to the Security tab. 4. Set security level to low. 5. Click Sites. 6. Add <code>http://machine-name:18170/MartAdmin/</code> or

Mart Portal Name in Korean	<p>Suppose that you provide the Mart Portal machine name in the Korean language (Korean characters) and configure the Mart Portal.</p> <p>If you try to connect to the Mart from erwin DM and you provide the Korean language name for Server Name, the following message appears: "The client application version is different from the Mart Portal version. Install the same version of the application and the Mart Portal and then try."</p> <p>If you try to log in to erwin Mart Portal by using the Korean language name, it does not display.</p>
Error While Creating a Profile Using Special Characters in Mart Portal	<p>When you create a profile in Mart Portal using special characters such as !@#\$%^&*()_+={}:"-<>? /.,;'[], and space, you will get one of the following error messages repeatedly and the Mart Portal hangs.</p> <p>Illegal Group</p> <p>or</p> <p>500 The call failed on the server; see server log for details</p> <p>or</p> <p>String index out of Range:1</p> <p>To avoid this error, create a profile without using the special characters.</p> <p>When the Mart Portal hangs, refresh the Mart Portal.</p>
Generating Reports with Korean Characters in User Name	<p>Suppose that you have initialized a Mart with a user name that</p>

The report is not generated and the message, You can not connect. Incorrect log on parameters is displayed. (The actual message is displayed in the Korean language. The message provided here is the translated message.)
DM Connect for DI: Valid values are not exported, if the name exceeds 200 characters	When you use the validation rules, valid values are not exported to DI if the names exceed 200 characters.
Variance in NSM Reports in erwin DM	Edit NSM option and few variances are noticed after running the report
DM-DI Connect: Validation Rule Valid Value properties are not displaying in an order	Validation Rule of Valid Value property values are not displaying in a sequence order for each valid Value. Currently its displaying the order based on the value its created first.

Metadata browser- Data types are not getting changed after applying the DSM in Dataflow impact analysis	After applying the DSM the data types are not getting changed from logical to physical
